Starting Monday, November 24th through Friday, December 19th, 104.1 EZ-FM jocks will give listeners the cue to call into the EZ studios at 515-280-1041 during the contesting hours of 10:00 AM to 6:59 PM. Each weekday, listeners will have two chances to call in and win—once with Kate between 10:00 AM and 3:00 PM, and once with Tony between 3:00 PM and 7:00 PM. When listeners hear the cue to call, caller number 10 will win a random prize from the assortment listed above. Prizes will be assigned at random; listeners cannot select a specific prize. Each prize will be drawn from the EZ "stocking" and awarded to the winner.

Please note: There will be no on-air contesting on Thanksgiving (Thursday, 11/27) and Black Friday (Friday, 11/28).

There will also be an online second-chance opportunity for those who do not win on-air. The online second-chance entry period closes on Sunday, December 21st at 11:59 PM. Online winners will be selected at random from the collected entries and contacted the following week.
